






Shipping and Ports in the TWSC

- High social and economic importance, among the busiest areas, Wadden Sea is sensitive to the impact from shipping
- It is considered among the priority issues for TWSC but sensitive and challenging
 - i.a. PSSA 2002, WSP, Sylt Declaration 2010, Tønder Declaration 2014, and SOUV
 - Addressed in the past in i.a. TG-Shipping and Shipping Group of the WSF
- Increasing concerns of the society of the Wadden Sea Region about negative impacts of the shipping business expressed by WSF, WST, Advisory Boards



 - Non-governmental bodies, e.g. related to nature, shipping, ports, pilots, etc.
 - Selected telephone and live interviews (in-depth)

- *Preliminary* results of the online survey:
 - Responders: 20 out of 50 (40%)
 - 40% (green) NGO
 - 35% Government
 - 25% Associations/Organisations
 - Basic attitude: cooperation and collaboration
 - Main items mentioned:
 - Information exchange
 - Raise mutual understanding
 - Jointly improve Wadden Sea protection
 - Balancing of economic development and ecologic preservation










• Base for reflexion: E.g. of the issue regarding "open loop sulphur scrubbers" in the Wadden Sea


